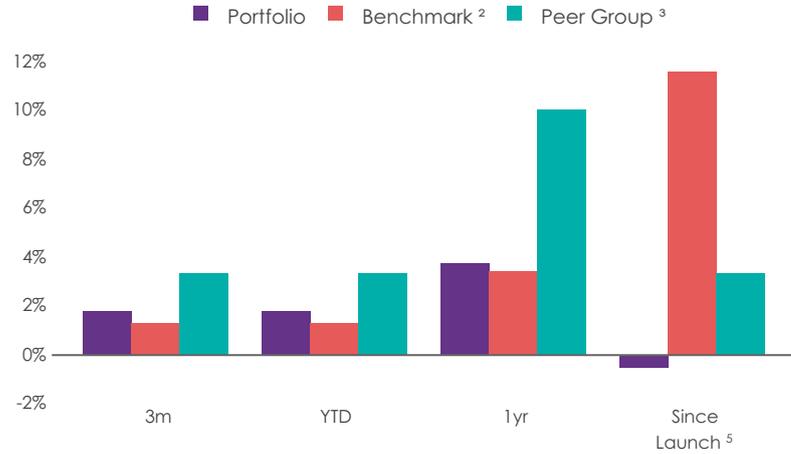
Portfolio objective

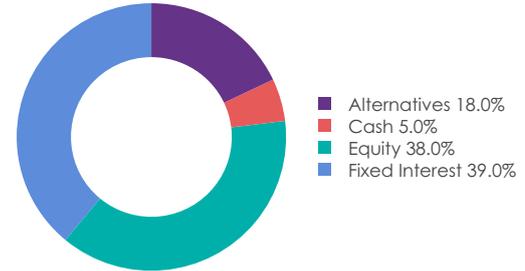
Risk

Investors should be able to tolerate a loss of up to 12.5% of the value of their portfolio in any one year, based on the assumption of 95% probability.

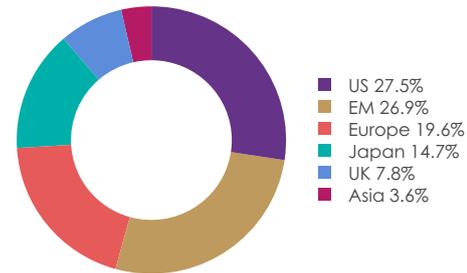

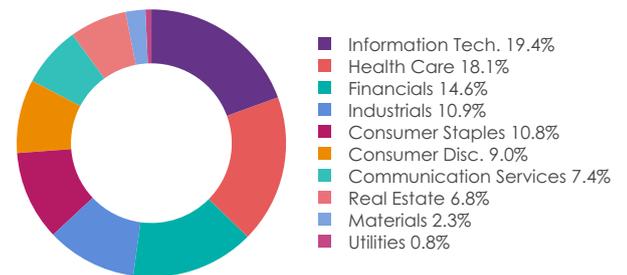
Asset breakdown
