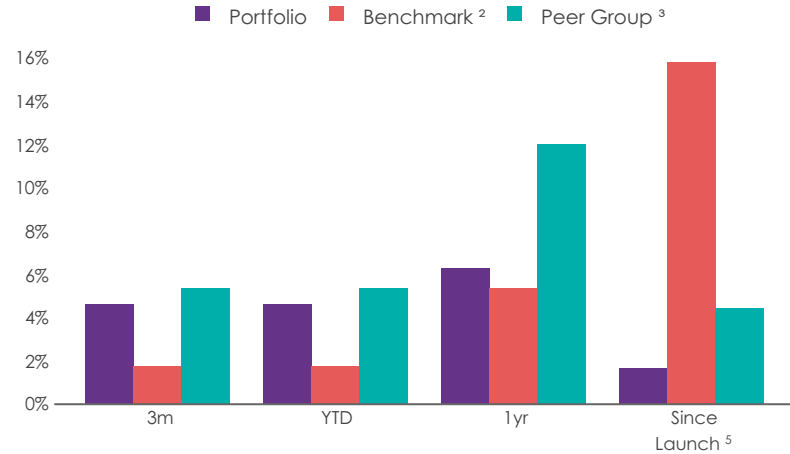
## Portfolio objective

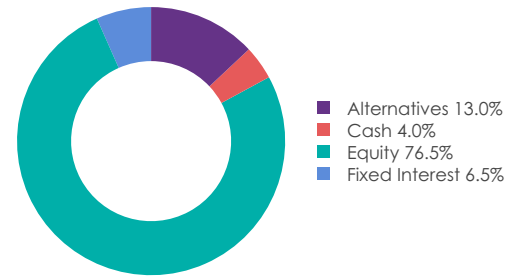
## Risk

Investors should be able to tolerate a loss of up to 20% of the value of their portfolio in any one year, based on the assumption of 95% probability.

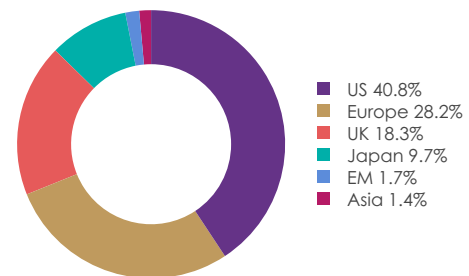

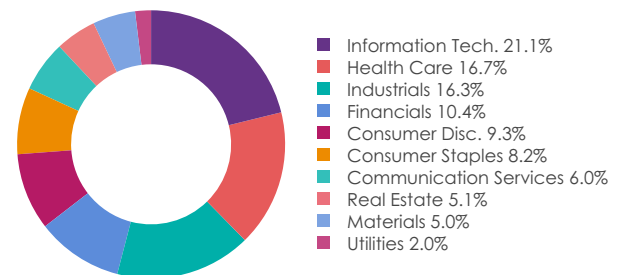
## Asset breakdown
